1. Approval of Agenda:

2 Business Arising:

a) CHPCA Funding and requirements

Fil announced that Bayshore Home Health has agreed to support our teleconferences and meetings with \$5,000/year for two years. Bayshore wants to join us at our meetings as an observer. 2b) Name of our group

All agreed to Canadian Network of Pediatric Hospices (CNPH)

2c) Approval of CNPH a official subcommittee of CNPCC

CNPCC approved CNPH as an official subcommittee. CNPCC is under the umbrella of the CHPCA. We are meant to be a forum for free-standing hospices.

2d) Approval of CNPH represented at CNPCC

Both Fil and Michelle sit on CNPCC and CNPCC have agreed to always have a member of CNPH on CNPCC.

2e) Approval of use of CNPCC website

CNPCC agreed to share the website www.cnpcc.ca with us. All agreed this is a good idea. Everyone is encouraged to visit the site and consider info to put on there for us.

3. New Business

a) Staffing Models—

Maison Andre Gratton--1 RN, 1RPN, and nurses aids as required;

Canuck Place—1 RN for every 4 pts on acuity scale and RPNs and PCAs as required under the RN;

Roger's House—1RN required 24/7. Other staff scheduled as needed based on experience.

Medical Director paid at Canuck Place and Maison Andre Gratton; Roger's House has a Medical Director paid by the hospital.

Action: Rauni to call Lloyd re how Medical Director works between hospital and hospice.

3b) Intake/discharge processes and forms

3c) Terms of Reference

Action:

i) Use CNPCC template to draft Terms of Reference (Lloyd)

ii) We should review the mandate of CNPCC so as not to duplicate. It is on the CNPCC website. (All)

iii) Gillian willing to mail hard copies of the national guidelines and norms of practice and Quebec Standards of Practice. E-mail her with your contact info if you would like a copy.

iv) Michelle is willing to share the Quebec adult hospice standards and Rauni can share the Ontario standards and Fil can share BCs.

v) Michelle will re-send contact list and all will add mailing addresses and phone and fax numbers.

3d) Building Use of pediatric palliative care by health care professionals

Need to build early referrals to hospice on a unit by unit and clinician by clinician basis. Respond to needs when they present. Need to be patient.
