3. Business Arising

a) Update on CHPCA conference 2010 (Sharon, Cheryl and Lloyd)

- · "Why are we so hungry to feed", withholding fluids and food at End of Life care.
- · Dr Lieben, Dr Rappaport are on panel.
- Action: Lloyd will ask Dr Nuala Kenny if she would be willing to join the panel.

b) Marketing Pediatrics at time of CHPCA conference (Sharon)

c) Pediatric Palliative Care at CHPCA Conference(Sharon)

- Need to look at increasing distribution of information about CHPCA and Meetings to pediatricians. There are currently 5000 people on the CHPCA email list but this mainly targets adult and family medicine.
- Action: Sharon and Cheryl will work on revising the flyer to highlight the Pediatric sessions at the conference and will forward the flyer to this group to distribute across their areas. They will also forward out a PDF version to distribute via email.

d) Hospice definition - English (Chervl) and French (Lyse)

• In Quebec they don't use the Term Hospice. They refer to "House" or "residence" for a residential hospice and "palliative care" to encompass the philosophy of "hospice".

e) (Addition) Parent Panel

- Looking for two more panel members for the parent panel at the CHPCA Conference
- Discussion topic is regarding important issues in Family Centered Care.
- There is unfortunately no funding to bring parents in.

g) (Addition) Parliamentary Committee of Palliative Care

- First Day of Testimony was the 2nd week in June.
- It's an ad hoc group with about 35 members with representatives from all the different parties.
- Plan is to develop a position statement for Palliative Care across the Country and goals or suggestions for new legislation.
- This would potentially influence e Federal Legislation not sure how this will impact on a Provincial level.
- · There are ongoing round table discussions.
- > Action:
 - Sharon will provide information to each of members of the committee re what was presented in her meeting with the Parliamentary Committee
 - Suggested that each pediatric Hospice representative provide a written brief to the committee if not able to speak in front of them to further their understanding of the critical aspects of Hospice and Palliative Care for children.

a) Action Plan re Goals #4, 5, 6 from Terms of Reference

- · Discussion regarding
 - "Standards" OR "Norms of Practice"
 - There are several documents already in existence for Standards and Norms of practice including but not limited to CHPCA Pediatric Norms of Practice, Quebec's "Pediatric Standards", In addition HAO has a draft of "Residential Hospice Standards of Practice".
 - Canuck Place has also been through Accreditation Canada for 'Pediatric Residential Hospice'.
 - It is important to question whether there are any gaps wrt Standards and potential purpose of any new document.
 - Action
 - ➤ Janet and Marli will discuss with Fil Accreditation Canada process to see what their emphasis was and where there may be gaps in the available documentation of appropriate standards for operational aspects of a pediatric residential hospice/House
 - Rauni will share the draft from the HAO Manual with Members of the committee.

Goal # 4 - Educate other health care professional about pediatric residential hospice care.
